

## **AKIN TEKSTİL A.Ş. CLARIFICATION TEXT**

This clarification text has been prepared by Akın Tekstil A.Ş (hereinafter referred to as “Akın”) as the data controller in order to inform you, our all visitors, including customers, suppliers, potential customers, employees, candidate employees, investors (hereinafter referred to as visitors), regarding the processing, storage and transfer of your personal data within the scope of the Law on the Protection of Personal Data No. 6698 and other relevant legislation. We declare that we will process your personal data stated below in all circumstances:

- In accordance with the law and good faith,
- By maintaining the accuracy and the most up-to-date version of the personal data that you shared,
- For specific, explicit and lawful purposes,
- In a way that is associated, limited and proportioned for the purpose for which they will be processed,
- By keeping them for the period required for the purpose for which they are processed or stipulated in the relevant legislation.

processed on the basis of the legal reason that the fact that data processing is mandatory for making offers, requests, suggestions and complaints by using the contact form on our company's website and in case of your feedback requests for execution of marketing and sales activities, execution of company/product/services loyalty processes, execution of communication activities, execution of customer relationship management processes, execution of activities for customer satisfaction, follow-up of requests/complaints and for the legitimate interests of the data controller, provided that it does not contradict the personal rights and personalities specified in Article 5 of the Law No. 6698.

- **Collection Method of Personal Data**

Your transaction security data mentioned above are collected by using the visitor offer, information and request form on our company's website to make offers, requests, suggestions and complaints, and by filling out the contact forms for your feedback requests.

### **To whom and for what purpose do we transfer your personal data.**

As Akın Tekstil A.Ş, we do not share the personal data of our employee candidates with any person or institution other than authorized persons or institutions.

### **How long we store your personal data**

If a period of time is determined for the storage of your personal data in the law or in the relevant legislation, the said data must be stored for at least this period. If a period is not stipulated in the law or the relevant legislation, it will be able to store the data about you for reasonable periods determined in connection with the purposes of the processing, limited and proportioned and until the reasons that require processing of the data about you are eliminated.

## **What are your rights as a data owner?**

You have the right to learn whether your personal data is processed, to request information about your processed personal data, to learn whether it is used in accordance with the purpose of processing, to know the third parties to which your personal data is transferred, to request correction of your personal data in case of incomplete or incorrect processing, to eliminate the reasons that require processing even though it has been processed in accordance with the law, to request the deletion or destruction of personal data ex officio or upon request and to request that the transactions made upon this request be notified to the third parties to whom the personal data is transferred, when the personal data is requested to be corrected, deleted or destroyed, to object to the emergence of a result against you by analyzing your processed personal data exclusively through automated systems. The application to be duly made by the personal data owner will be answered by Akın Tekstil A.Ş within thirty days at the latest, depending on the nature of the request.

## **How you can use your rights as a data owner?**
